Following its establishment on 1 March 2006, the Sepp Blatter Foundation has now completed its seventh financial year.

The foundation's annual report for 2012 is presented below.

1. Board of Management

2. Foundation activities

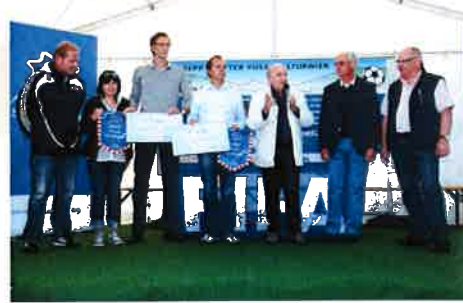
Presentation of 2011 award in Ulrichen on 26 August 2012

The 2011 Sepp Blatter Foundation Award was officially presented at the Sepp Blatter Football Tournament in Ulrichen, Valais on Sunday, 26 August 2012.

Having examined the dossiers, the Board of Management decided to grant the award of CHF 20,000 to the Wiler and Kippel communities in the Lötschental region (CHF 10,000 each).

Lötschental had suffered severe damage, amounting to millions of francs, as a result of the serious floods in autumn 2011 and both football pitches in the villages of Wiler and Kippel were very badly damaged.

With this award, the Sepp Blatter Foundation wished to help football enthusiasts in Löttschental repair their pitches so that they could once again pursue their favourite hobby.



Meetings of the Board of Management

The Board of Management held the following meetings in 2012:

- Ordinary meeting no. 15 held in Zurich on 12 April 2012
- Ordinary meeting no. 16 held in Visp on 31 October 2012

The most important decisions were as follows:

Meeting no. 15, Thursday, 12 April 2012

- Final approval of the financial statement for 2011 and of the balance sheet as at 31 December 2011

Decision:	- Allocation to the donation fund of:	CHF	145,000.00
	- Amount carried over of:	CHF	13,870.25

- Confirmation of the granting of the 2011 Award, worth CHF 20,000, to the communities of Wiler and Kippel in Löschentäl to repair their football pitches damaged by the storm.
- Analysis of and decision on three applications for financial support, in particular the approval of an application from FC Turtmann for a donation of CHF 1,000 towards the club's tournaments for "E"- and "F"-level youngsters, and the approval of a donation of CHF 2,500 to the singing school Cantiamo Oberwallis. Regarding the request from the Forum Migration Oberwallis, it was decided to provide support in the form of 30 adidas balls.
- Decision to promote the foundation's positive activities via Twitter. First Tweet sent out during the meeting.
- Presentation of the Annual Report 2011.



Meeting no. 16, Wednesday 31 October 2012

- Confirmation of the granting of the 2012 Award, worth CHF 20,000, to the Martinsheim care home in Visp. Martinsheim, a care home for older people, does outstanding work and exhibits great social commitment as well as providing high-quality expert care to the residents of the home in Visp.

- Analysis of and decision on seven applications for financial support, in particular the approval of an application from the Tandem 91 Foundation in Steg for a donation of CHF 2,500.
- Presentation of the Spanish and Italian versions of the website and its new section about past awards.
- Confirmation and ordering of 1,500 mini balls with the logo of the foundation, and a photo wall.



3. Donations to the foundation

During the reporting year, the foundation again received donations from friends and acquaintances of the members of its Board of Management and from other donors.

A total of CHF 126,510.70 was donated during the reporting year.

A big thank you to all donors for their support.

4. Revenue and expenses

Expenses of CHF 3,968.15 were incurred during the reporting year. This sum consisted of the following:
