Annual Report 2010

Following its establishment on 1 March 2006, the Sepp Blatter Foundation has now completed its fifth financial year.

The foundation's Annual Report for 2010 is provided below.

1. Board of Management

The Board of Management has been composed of the following persons since 2006:

2. Activities

Presentation of 2009 award in Ulrichen on 29 August 2010

The 2009 award was officially presented at the Sepp Blatter Football Tournament in Ulrichen, Valais on Sunday, 29 August 2010.

After carefully assessing the candidates' merits, the Board of Management decided to present an award of CHF 10,000 to both the regional football associations of the Gommer Fussball Meisterschaft and the Bergdorf Meisterschaft.

Through their organisation of competitions, their commitment and their support for football, as well as through the development of women's football in their regions, these associations promote social, cultural and educational values among young people which are close to the foundation's heart, such as respect, discipline, team spirit and fairness.

Meetings of the Board of Management

The Board of Management held two ordinary meetings in Visp in 2010 (6 February and 30 October).

The most important decisions were as follows:

Meeting no. 10, Saturday, 6 February 2010

- Final approval of the financial statement for 2009 and of the balance sheet as at 31 December 2009

Decision: - Allocation to the donation fund of: CHF 50,000.00
 - Balance carried forward of: CHF 11,126.47

- Confirmation of 2009 awards, each worth CHF 10,000, to the two regional football associations of the Gommer Fussball Meisterschaft and the Bergdorf Meisterschaft
- Analysis of and decision on five applications for financial support, in particular the approval of an application from FC Turtmann for a donation of CHF 1,000 towards tournaments for “E”- and “F”-level youngsters
- Approval of the structure and content of the foundation’s brochure, including the new logo
- Decision on the foundation’s stationery and the new logo
- Presentation of the video message by Franz Beckenbauer

Meeting no. 11, Saturday, 30 October 2010

- Decision on a discretionary mandate at the Walliser Kantonalbank Visp and an investment worth CHF 750,000 (investment strategy: WKB Active Portfolio “Sicherheit”)
- Presentation of the 2010 award, worth CHF 20,000, to the Fux Campagna residential home in Visp
- Analysis of and decision on eight applications for financial support, in particular the approval of an application from the Upper Valais Diabetes Society Foundation for a donation of CHF 2,000

- Presentation of the annual report 2009
- Presentation of the video messages by Michel Platini and Christian Karembeu
- Appointment of Thierry Hischier as the foundation's website manager
- Production of a banner for the Sepp Blatter Golf Tournament in August 2011

3. Donations to the foundation

During the reporting year, the foundation again collected funds from the circle of the members of its Board of Management and other donors.

A total of CHF 259,408.10 was donated during the reporting year.

A big thank you to all donors for their support.

4. Revenue and expenses

Expenses of CHF 25,990.14 were incurred during the reporting year. This sum consisted of the following:


