Annual Report 2014

Following its establishment on 1 March 2006, the Sepp Blatter Foundation has now completed its eighth financial year.

The foundation's annual report for 2014 is presented below.

1. Board of Management

2. Foundation activities

Presentation of 2013 award in Glis on 12 April 2014

The 2013 Sepp Blatter Foundation Award was officially presented to *insieme oberwallis* in Glis on Saturday, 12 April 2014.

The Board of Management of the Sepp Blatter Foundation is very impressed by the commitment of the institution, and at its last meeting on 31 October 2013 decided to give the 2013 award, worth CHF 20,000, to *insieme oberwallis* in Glis. In doing so, the Sepp Blatter Foundation wishes to make a contribution towards ensuring that the well-being of people with special requirements in German-speaking Valais and the quality of care remains at a high level.

Over the course of its 50-year history, *insieme oberwallis* has grown into the largest social institution in the canton of Valais. At *insieme oberwallis*, around 300 professionals provide 500 children and adults with special requirements with dedicated care on a daily basis.

Meetings of the Board of Management

- Ordinary meeting no. 19 held in Visp on Friday, 11 April 2014
- Ordinary meeting no. 20 held in Visp on Friday, 31 October 2014

The most important decisions were as follows:

Meeting on 3 February 2014

- Accountancy and reporting to be performed by Zenhäusern Treuhand AG
- Corinne Blatter Andenmatten to be given sole signatory authority at Walliser Kantonalbank
- Payments in the future to be made via online banking
- New distribution of tasks

Meeting no. 19 on 11 April 2014

- Final approval of the financial statement for 2013 and of the balance sheet as at 31 December 2013

Decision: - Allocation to the donation fund of: CHF 90,000.00
 - Amount carried over of: CHF 4,219.45

- Analysis of and decision on five applications for financial support, in particular the approval of an application from FC Turtmann for a donation of CHF 2,000 towards tournaments for “E”- and “F”-level youngsters
- Presentation of the updated version of the website
- Presentation of new testimonials from [Pelé](#), Cafu, Hierro, Cannavaro and Matthäus
- Presentation of the Annual Report 2013

Meeting no. 20 on 31 October 2014

- The 2014 award is still open. Discussions on whether to present the award to FC Oberwallis Naters AG.
- The award was increased to CHF 25,000.
- Analysis of and decision on six applications for financial support, in particular the approval of an application from FC Mörel-Filet for an extension to changing rooms at the "Sand" football pitch: donation of CHF 3,000.
- Presentation of the balance sheet and income statement for the January-October 2014 period.
- Written testimonial from *insieme oberwallis* still not received.
- Personal Twitter account of Sepp Blatter to be linked to that of the foundation.
- Two-page brochure still being revised.



3. Donations to the foundation

During the reporting year, the foundation again received donations from friends and acquaintances of the members of its Board of Management and from other donors.

A total of CHF 19,284.80 was donated during the reporting year.

4. Revenue and expenses

Expenses of CHF 27,746.75 were incurred during the reporting year. This sum consisted of the following:
